

Unapproved Minutes

Minutes of the regular meeting of the Board of Alderman of the City of Pilot Grove, Missouri, (City Council) held at 6:00 pm on December 9, 2024 at City Hall, located at 213 College Street in the City of Pilot Grove, Missouri are as follows:

1. The regular meeting of the Pilot Grove City Council was called to order. Those present included: Council members, Bob Kraus, Donna Bader, Bradley Vollmer, and Kathy Waller, Mayor Dennis Knipp, City Clerk Lori Vollrath, and Chief of Police Pete Busalacki. Also, in official attendance was Kendra Twenter representing residents of West Bock Street.
2. The agenda for this meeting was accepted by motion and second and vote.
3. Public Concerns and Comments: Guest Kendra Twenter brought concerns with the Prairieland FS operations and the effects on the community and asked the council for the City's help with expressing these concerns to Prairieland FS officials.
Other guests' comments and concerns: Concerns were expressed by many city residents about proposed Ordinance 119 that would amend Section 410.220 (Foundation Requirements of manufactured, modular, and mobile homes) and proposed Ordinance 120 that would amend Paragraph A of Section 300.020 of Chapter 300 regarding parking regulations and hinderances set.
4. Minutes of the prior meeting on November 4, 2024 were accepted by motion, second and vote.
5. The financial reports for November 2024 were presented and accepted on motion and second and vote.
6. The Police Report for November 2024 was presented and accepted on motion and second and by vote.
7. Old Business
 - a) Ordinance 119: Ordinance 119 that would amend Section 410.220 (Foundation Requirements of manufactured, modular, and mobile homes) was tabled indefinitely by motion, 2nd, and vote.
 - b) Ordinance 120: Having been made previously available, Mrs. Vollrath read, by title only, Ordinance 120 amending and restating in its entirety Paragraph A of Section 300.020 of Chapter 300 of the City's Code of Ordnances by adding an additional offence numbered 7 (No parking Between signs) to the existing list of offenses and setting hinderances for such offenses. Ordinance 120 was passed by motion, second, and roll call of votes.
 - c) FYI: A new emergency siren is to be ordered by EMA Director, Larry Oerly this week w/ installation expected in the Spring
8. New Business
 - a) On motion, 2nd, and Vote with the lease expiring, the present City Hall copier will be purchased with a low monthly maintenance fee.
 - b) On motion, 2nd, and Vote, the Mayor was given authority to renew C.O.D.s at the three banks containing such.
 - c) On motion, 2nd, and Vote, the 2 recycling center helpers will be gifted \$150 for their yearly efforts.
 - d) On motion, 2nd, and Vote a plans for a building permit were accepted.
9. Closed Meeting: The meeting was not closed
10. The meeting was not closed therefore no actions taken.
11. The meeting was not closed therefore no need to reconvene.
12. No further actions taken in Open Session
13. The date of the next regular council meeting is scheduled for Monday, January 6, 2025 at 6:00 p.m.
